## Elk Creek Fire Protection District Election Board of Directors

**Vote In-person on Tuesday, May 6th**

**or**

**Vote by Absentee Ballot**

**What is this election about?** This is a regular, odd-year Colorado Special District election that will elect two new board members to the Elk Creek Fire Protection District (FPD) Board of Directors for a four-year term from the top-two vote-getters among those running (the two current board members in these seats are term-limited so cannot run). **Where do I vote In-person in this election?** In-person voting will take place on Tuesday, May 6th at Elk Creek FPD Station 1, 11993 Blackfoot Road, Conifer CO 80433 from 7am to 7pm, please see map below and also: [Acceptable Forms of ID](#)

**How can I vote by Absentee Ballot in this election?** Even though this election has been determined to be a Polling Place Election—you may decide at anytime, for any reason, or for no reason—to vote by absentee ballot, as follows:

1. Request your Absentee Ballot by contacting the Elk Creek FPD DEO (Designed Election Official) Sarah Shepherd by email at: [info@ccrider.us](mailto:info@ccrider.us) or by telephone at: (303) 482-1002, anytime before April 29th, then follow step 2)

below **OR** you can download the official APPLICATION FOR ABSENTEE BALLOT: [here](#) then print, complete, and sign the application with a "wet" signature. You can then either, scan the document to create a PDF/JPEG or take a photo with a digital camera, then email the digital copy of your completed application to: [info@ccrider.us](mailto:info@ccrider.us), then follow step 2) below.

2. After marking your Absentee Ballot, can mail your ballot to Elk Creek FPD, P.O. Box 607, Conifer CO 80433 (please allow at least 5 business days for delivery) **OR** you—or anyone you choose—may return your voted ballot by placing it in the outside 24/7 drop box located at Elk Creek FPD Station 1, 11993 Blackfoot Road, Conifer CO 80433 (please see map above) **OR** you can bring your voted ballot with you on election day to Station 1 then present it to any Election Judge present who will then place it into the ballot box for counting.

**Note:** If your Absentee Ballot is late in arriving, please contact DEO Sarah Shepherd directly by telephone at: (303) 482-1002 to ask her how best to quickly obtain your ballot or a replacement.
