2. After marking your Absentee Ballot, can mail your ballot to Elk Creek FPD, P.O. Box 607, Conifer CO 80433 (please allow at least 5 business days for delivery) OR you—or anyone you choose—may return your voted ballot by placing it in the outside 24/7 drop box located at Elk Creek FPD Station 1, 11993 Blackfoot Road, Conifer CO 80433 (please see map above) OR you can bring your voted ballot with you on election day to Station 1 then present it to any Election Judge present who will then place it into the ballot box for counting.
